### **Management Discussion of Fund Performance**

#### **Investment Objectives and Strategies**

The investment objective of the Mawer Canadian Equity Fund (the "Fund") is to invest for above average long-term returns in equity securities of Canadian companies, principally those with market capitalizations greater than \$500 million. This objective is to be achieved by focusing on companies that can translate a competitive advantage into a return on capital; and by purchasing these companies at a discount to intrinsic value, as measured by a discounted cash flow model.

#### Risk

The Fund is suitable for investors seeking long-term growth and who have a medium tolerance for risk. General risks of investing in the Fund are outlined in the Prospectus and include the possibility of reduction in value of any given stock, liquidity risk, interest rate risk and currency risk, among others.

The Manager reduces the exposure to these risks by not concentrating more than 20% of the net assets of the Fund in a particular industry (i.e., sub-sector) as defined by the Global Industry Classification Standards (GICS). It is the Manager's policy to be fully invested (less than 5% in cash).

### **Results of Operations**

The Fund's net assets decreased 3.6% to \$3,570.8 million from \$3,704.0 million at June 30, 2024. Of this change, \$230.9 million is attributable to positive investment performance and -\$364.1 million was due to net redemptions to the Fund.

The Manager assesses the Fund's underlying securities for liquidity on a quarterly basis. During the period the Fund has remained in compliance with National Instrument 81-102 and has maintained an illiquid concentration of less than 10% of the Fund's Net Asset Value. During the period there were no notable redemptions to the Fund that affected its liquidity.

Over the six-month period, the Fund's series A units' return was 6.0% (after deducting fees and expenses paid by the series) in comparison to the S&P/TSX Composite Index (Gross) return of 6.1%. All performance values provided are in Canadian dollar terms.

When assessing relative performance, security selection was positive, aided by the strong performance of the holdings in Technology and Utilities. The sector allocation was, however, negative.

At the security level, there were several contributors. Loblaw Companies Limited continued to report solid earnings albeit with decelerating growth. Margin expansion through operating leverage and positive sales mix shift from Loblaw to Shoppers Drug Mart (a higher margin segment) continues to drive improved overall profitability.

### **Mawer Canadian Equity Fund**

Integrated oil giant Canadian Natural Resources Limited was supported from strong oil prices. With the expansion of the Trans Mountain Pipeline, the company should benefit from improved crude oil pricing going forward. Dollarama Inc. reported strong but moderating growth in Canada, and beyond Canada, the company announced a deal to acquire an additional ten percent of Dollarcity and a new joint venture with the management team to enter Mexico in 2026. Adding Mexican operations may provide an additional long-term growth runway as Canada matures.

Meanwhile, after a strong finish to 2023, The Toronto-Dominion Bank shares traded lower. The bank continues to be one of the top two bank picks in the fund due to its scale and low funding costs, but recent turnover amongst the executive ranks does lower the management score's perception for the company at the margin. Bank of Montreal also traded lower as it noted higher than expected credit loss provisions as high interest rates continue to stretch borrowers.

Over the past six months, the position was initiated in Boyd Group Services Inc., a top two network of collision repair shops in the U.S. and Canada. The industry is highly fragmented but consolidating and Boyd has demonstrated a strong capital allocation track record. The company enjoys strong revenue growth and cost advantages from scale with prudent use of debt and strong underlying business execution. There were no eliminations during the period.

The period marked the start of the next phase of the cycle, one where the Bank of Canada now officially has a bias towards easing policy rates. The questions remain when and at what pace there will be further rate cuts. Our current view is that inflation may remain sticky, and as a result, cuts could be slower than market consensus. The interplay between growth, inflation, and interest rates will likely have a large effect on the Canadian equity market in the coming quarters.

Thinking longer-term, we worry about the trend toward more protectionist policies, less globalization, more conflict, and a multi-polar world. In 1989, the fall of the Berlin Wall was an inflection point that served to catalyze more inclusive global economic growth, increased productivity, trade, and formidable stock market returns over the ensuing three decades. While global economic growth remains positive, it has slowed and we note that the word "deflation" has started to occasionally creep into conversations with company executives, a shift relative to the last few years. Current trends, along with a higher cost of capital, may imply lower real returns from equities moving forward.

As for the non-Canadian Al-related market darlings which have surged ahead and caused the Canadian equity market to lag many regions globally, the late Roy Amara once said, "We tend to overestimate the effect of a technology in the short run and underestimate the effect in the long run." Put differently, there's a risk of over-exuberance in markets extrapolating today's pace of Al-related demand, with many companies lacking the data or infrastructure to deploy generative Al widely within their organizations. Return on investment is also unknown. But the mismatch between the timing of investment and returns may create significant future opportunities, particularly where competitive advantages are strongest.

As always, valuation is the great equalizer and both axes of our Matrix—quality and valuation—are important. Al-related or not, companies with competitively advantaged revenue streams should benefit from continued economic growth while providing a measure of defensiveness should the macroeconomic environment deteriorate. Purchasing such securities at a discount to their intrinsic values should, in theory, offer greater upside in a bullish scenario yet better downside protection should markets correct. We aim to get the balance right. While not a formula for avoiding shorter-term negative returns, we believe this approach should minimize the probability of permanent impairment of capital while leading to long-term compounding of wealth.

#### **Recent Developments**

There are no recent developments to report related to the strategic positioning of the Fund, the Manager, or the policies of the Independent Review Committee.

# Related Party Transactions – Management Fees

The Portfolio Advisor receives management fees, which are calculated for Series A Units as 1.00% per annum of the net asset value of the Fund calculated on a daily basis. Management fees for Series O Units are payable directly to the Manager by Series O investors and not by the Fund.

The Manager of the Fund has the ability, at their discretion, to reduce the management fees for large investors. This reduction is effected by means of a management fee distribution and will be automatically reinvested in additional units of the Fund at the net asset value of the Fund on the date of distribution. Mawer also receives fees for performing administrative services. As at June 30, 2024 the Fund owes Mawer \$0 related to these administrative services.




### Year-by-Year Returns
