# **Management Discussion of Fund Performance**

### **Investment Objectives and Strategies**

The objective of the Mawer Global Equity Fund (the "Fund") is to invest for above-average risk-adjusted returns in securities of companies around the world. This is done by choosing companies that we believe will be wealth-creating in the long-term and are trading at a discount to their intrinsic value. We prefer companies with enduring competitive advantages that will allow them to earn a return greater than their cost of capital over the long-term. The Fund has a long-term buy-and-hold strategy and seeks to keep turnover low.

#### Risk

This Fund is suitable for investors seeking long-term growth and who have a medium tolerance for risk. General risks of investing in this Fund are outlined in the Prospectus and include the possibility of reduction in value of any given investment, liquidity risk, interest rate risk, and currency risk amongst others.

The Manager reduces the exposure to these risks by not concentrating more than 20% of the net assets of the Fund in a particular industry (i.e., sub-sector) as defined by the Global Industry Classification Standards (GICS). The Fund typically invests in global corporations with a market capitalization of \$3 billion (USD) or more at the time of purchase. The Fund also typically keeps its Emerging Market weight to less than 20% of the Fund's market value as defined by countries within the MSCI Emerging Markets Total Return Index. The Fund also invests a maximum 75% of the Fund's market value in the United States and a maximum 25% of the Fund's market value in any other country not mentioned above.

## **Results of Operations**

The Fund's net assets increased 10.0% to \$13,407.7 million from \$12,190.4 million at June 30, 2024. Of this change, \$833.3 million is attributable to positive investment performance and \$384.0 million was due to net contributions to the Fund.

The Manager assesses the Fund's underlying securities for liquidity on a quarterly basis. During the period the Fund has remained in compliance with National Instrument 81-102 and has maintained an illiquid concentration of less than 10% of the Fund's Net Asset Value. During the period there were no notable redemptions to the Fund that affected its liquidity.

Over the six-month period, the Fund's series A units' return was 6.2% (after deducting fees and expenses paid by the series) in comparison to the MSCI ACWI (Net) return of 15.5%. All performance values provided are in Canadian dollar terms.

In terms of relative performance, it was mainly the security selection that led to relative underperformance. In particular, security selection in Technology, Financials and Industrials, negatively impacted performance. Sector allocation was also negative. At the stock level, after an excellent 2023, Brazilian broker-dealer XP Inc. traded lower in sympathy with broad-based weakness in Brazilian financial markets. Investors were concerned about the fiscal spending ambitions of the left leaning federal government. Coffee marketer and distributor JDE Peet's has had some challenges as increased pricing to offset inflation has caused some consumers to down-trade and some retailers to push back on premium pricing.

On a positive note, Novo Nordisk, the diabetes focused pharmaceutical company, reported strong earnings as weight loss drug demand continued to outstrip supply. Microsoft and Alphabet both saw excellent growth in their cloud computing businesses and for Alphabet, the main concern from the past year that generative AI will materially impair Google's search business, appears to be waning as the company integrates AI technology into its search product.

We also initiated positions in Deere & Co and Snap-on Inc. Deere & Co is a dominant agriculture, turf, construction, and forestry equipment manufacturer which is increasingly integrating technology and software into its hardware. The company spends one and a half times more on research & development than the #2 and #3 agricultural players combined. There is good management alignment with a long-tenured team and strong compensation incentives that include economic valueadd and return on capital metrics. Snap-on Inc is a vertically integrated manufacturer of premium tools/diagnostic equipment selling to professional car repair technician/shops and industrial customers. The company has scale in a niche industry, a fragmented customer base, brand loyalty, and an attractive captive finance business. Some of the notable exits included Intuit and Dun & Bradstreet. Intuit is an accounting and tax software provider. Intuit remains a high-quality business model with scale, pricing power, and a recurring subscription model, but in our view, it requires very aggressive growth and margin assumptions to justify the current valuation. Dun & Bradstreet is the world's largest business-tobusiness credit check company. Organic growth, margin improvement and cash conversion have all lagged our expectations.

Thinking longer-term, we worry about the trend toward more protectionist policies, less globalization, more conflict, and a multi-polar world. In 1989, the fall of the Berlin Wall was an inflection point that served to catalyze more inclusive global economic growth, increased productivity, trade, and formidable stock market returns over the ensuing three decades. While global economic growth remains positive, it has slowed and we note that the word "deflation" has started to occasionally creep into conversations with company executives, a shift relative to the last few years. Current trends, along with a higher cost of capital, may imply lower real returns from equities moving forward. As for the AI-related market darlings, the late Roy Amara once said, "We tend to overestimate the effect of a technology in the short run and underestimate the effect in the long run." Put differently, there's a risk of over-exuberance in markets extrapolating today's pace of AI-related demand, with many companies lacking the data or infrastructure to deploy generative AI widely within their organizations. Return on investment is also unknown. But the mismatch between the timing of investment and returns may create significant future opportunities, particularly where competitive advantages are strongest.

As always, valuation is the great equalizer and both axes of our Matrix quality and valuation—are important. Al-related or not, companies with competitively advantaged revenue streams should benefit from continued economic growth while providing a measure of defensiveness should the macroeconomic environment deteriorate. Purchasing such securities at a discount to their intrinsic values should, in theory, offer greater upside in a bullish scenario yet better downside protection should markets correct. We aim to get the balance right. While not a formula for avoiding shorter-term negative returns, we believe this approach should minimize the probability of permanent impairment of capital while leading to long-term compounding of wealth.

## **Recent Developments**

There are no recent developments to report related to the strategic positioning of the Fund, the Manager, or the policies of the Independent Review Committee.

#### Related Party Transactions – Management Fees

The Portfolio Advisor receives management fees, which are calculated for Series A Units as 1.15% per annum of the net asset value of the Fund calculated on a daily basis. Management fees for Series O Units are payable directly to the Manager by Series O investors and not by the Fund.

The Manager of the Fund has the ability, at their discretion, to reduce the management fees for large investors. This reduction is effected by means of a management fee distribution and will be automatically reinvested in additional units of the Fund at the net asset value of the Fund on the date of distribution. Mawer also receives fees for performing administrative services. As at June 30, 2024 the Fund owes Mawer \$0 related to these administrative services.




## Year-by-Year Returns

## **Annual Compound Returns**

The following table shows the historical annual compound total return of the Fund for the periods shown ending on June 30, 2024. The annual compound total return is benchmarked to the Mawer Global Equity Benchmark (GE Benchmark) and calculated on the same compound basis. The GE Benchmark is a composite return stream consisting of MSCI World Index (net) from inception to September 30, 2016 and the MSCI ACWI (net), as of September 30, 2016. The MSCI ACWI captures large and mid cap representation across 23 Developed Markets (DM) and 26 Emerging Markets (EM) countries. All index returns are calculated in Canadian dollars on a total return basis, meaning that all distributions are reinvested.
