Management Discussion of Fund Performance

Investment Objectives and Strategies

The objective of the Mawer Global Small Cap Fund (the "Fund") is to invest for above average long-term returns in securities of smaller companies around the world. This is done by choosing companies that we believe will be wealth-creating in the long-term and are trading at a discount to their intrinsic value. We prefer companies with enduring competitive advantages that will allow them to earn a return greater than their cost of capital over the long-term. The Fund has a long-term buyand-hold strategy and seeks to keep turnover low.

Risk

This Fund is suitable for investors seeking long-term growth and who have a medium-to-high tolerance for risk. General risks of investing in this Fund are outlined in the Prospectus and include the possibility of reduction in value of any given investment, liquidity risk, interest rate risk, and currency risk amongst others.

The Manager reduces the exposure to these risks by not concentrating more than 20% of the net assets of the Fund in a particular industry (i.e., sub-sector) as defined by the Global Industry Classification Standards (GICS). The Fund typically owns positions in global corporations with a market capitalization of \$3 billion (USD) or less at the time of purchase. It is the Manager's intention to be generally fully invested (less than 5% in cash).

Results of Operations

The Fund's net assets decreased 4.6% to \$3,131.0 million from \$3,280.5 million at June 30, 2024. Of this change, \$5.8 million is attributable to positive investment performance and -\$155.3 million was due to net redemptions to the Fund.

The Manager assesses the Fund's underlying securities for liquidity on a quarterly basis. During the period the Fund has remained in compliance with National Instrument 81-102 and has maintained an illiquid concentration of less than 10% of the Fund's Net Asset Value. During the period there were no notable redemptions to the Fund that affected its liquidity.

Over the six-month period, the Fund's A series returned -0.6% (after management fees), in comparison to the blended benchmark returns of 6.1%, The blended benchmark consists of the Russell Global Small Cap Index from inception to September 30, 2016 and the MSCI ACWI Small Cap (Net) Total Return Index onwards. All performance values provided are in Canadian dollar terms.

When assessing relative performance by sector, stock selection was negative. In particular, the relative underperformance was concentrated in a handful of larger positions within the industrials sector. Sector allocation was slightly positive. When examining relative return from a geographical perspective, the Fund's underperformance is attributable largely to negative stock selection in the United States.

Mawer Global Small Cap Fund

At the security level, the outsourced R&D firm Alten S.A. was negatively impacted by investor sentiment around the French legislative election and increased uncertainty. Shares of GPS Global Payment Solutions, a facilities management company based in Brazil, were also unable to escape broad-based weakness in Brazilian financial markets tied to concerns over the fiscal spending ambitions of the left-leaning federal government even though the firm's earnings continue to grow. Drug store operator Tsuruha Holdings Inc. also continued to suffer from a pandemic hangover, with demand for COVID-19 related products declining.

On a positive note, value-added resellers Softcat plc and Atea ASA have both experienced a shift in demand from hardware to software, ultimately improving margins, while AI, data management, and cybersecurity have been notable growth drivers. The management team of accounting and advisory firm CBIZ, Inc. continued to execute on its very long growth runway as they focus on tuck-in acquisitions in what is a quite fragmented market where CBIZ holds a desirable position over competitors.

Over the past six months, some of the notable initiations included Alten S.A. and Volution Group plc. Alten is an engineering services company specializing in outsourced R&D. The perceived quality of Alten is excellent as the company operates in a decentralized manner, which has helped them gain market share in a growing industry characterized by increased complexity and customers that require constant innovation; areas bolstering demand for Alten's expertise. Volution is a manufacturer and distributor of ventilation products mainly for the residential market. Effective home ventilation is typically a minor component of refurbishment or new construction expenses and is crucial for maintaining air quality and preventing moisture buildup. Installers tend to prioritize trusted brand names renowned for their superior quality and reliability—such as Volution—avoiding the perceived uncertainties associated with lesser-known alternatives.

Meanwhile, some of the notable exits include dormakaba Holding AG and Tietoevry Corporation. Dormakaba is a global provider of locks and entrance systems and the assessment of management changed after they announced a change in leadership. The Tietoevry management was expected to spin off the banking services segment of this IT consulting firm—an area in which they have been losing market share to specialized consultants—to improve its overall operations, but ultimately decided to step back. This has negatively affected our assessment of the capability of management to unlock value and weighed in on the decision to exit the position.

Thinking longer-term, we worry about the trend toward more protectionist policies, less globalization, more conflict, and a multi-polar world. In 1989, the fall of the Berlin Wall was an inflection point that served to catalyze more inclusive global economic growth, increased productivity, trade, and formidable stock market returns over the ensuing three decades.

While global economic growth remains positive, it has slowed and we note that the word "deflation" has started to occasionally creep into conversations with company executives, a shift relative to the last few years. Current trends, along with a higher cost of capital, may imply lower real returns from equities moving forward.

As for the Al-related market darlings, the late Roy Amara once said, "We tend to overestimate the effect of a technology in the short run and underestimate the effect in the long run." Put differently, there's a risk of over-exuberance in markets extrapolating today's pace of Al-related demand, with many companies lacking the data or infrastructure to deploy generative Al widely within their organizations. Return on investment is also unknown. But the mismatch between the timing of investment and returns may create significant future opportunities, particularly where competitive advantages are strongest.

As always, valuation is the great equalizer and both axes of our Matrix—quality and valuation—are important. Al-related or not, companies with competitively advantaged revenue streams should benefit from continued economic growth while providing a measure of defensiveness should the macroeconomic environment deteriorate. Purchasing such securities at a discount to their intrinsic values should, in theory, offer greater upside in a bullish scenario yet better downside protection should markets correct. We aim to get the balance right. While not a formula for avoiding shorter-term negative returns, we believe this approach should minimize the probability of permanent impairment of capital while leading to long-term compounding of wealth.

Recent Developments

There are no recent developments to report related to the strategic positioning of the Fund, the Manager, or the policies of the Independent Review Committee.

Related Party Transactions - Management Fees

The Portfolio Advisor receives management fees, which are calculated for Series A Units as 1.50% per annum of the net asset value of the Fund calculated on a daily basis. Management fees for Series O Units are payable directly to the Manager by Series O investors and not by the Fund.

The Manager of the Fund has the ability, at their discretion, to reduce the management fees for large investors. This reduction is effected by means of a management fee distribution and will be automatically reinvested in additional units of the Fund at the net asset value of the Fund on the date of distribution. Mawer also receives fees for performing administrative services. As at June 30, 2024 the Fund owes Mawer \$0 related to these administrative services.




Year-by-Year Returns

All index returns are calculated in Canadian dollars on a total return basis, meaning that all distributions are reinvested.
