Management Discussion of Fund Performance

Investment Objectives and Strategies

The objective of the Mawer EAFE Large Cap Fund (the "Fund") is to achieve above-average long-term risk-adjusted returns and to create a diversified portfolio of equity and equity related securities of larger companies located in developed countries outside of Canada and the United States, primarily in Europe, Australasia and the Far East (EAFE). This is done by choosing companies that we believe will be wealthcreating in the long term and are trading at a discount to their intrinsic value. We prefer companies with enduring competitive advantages that will allow them to earn a return greater than their cost of capital over the long term. The Fund has a long-term buy and hold strategy and seeks to keep turnover low.

Risk

This Fund is suitable for investors seeking long-term growth and who have a medium tolerance for risk. General risks of investing in this Fund are outlined in the Prospectus and include the possibility of reduction in value of any given investment, liquidity risk, interest rate risk and currency risk amongst others.

The Manager attempts to reduce the exposure to these risks by not concentrating more than 20% of the net assets of the Fund in a particular Industry as defined by the Global Industry Classification Standards (GICS). The Manager provides diversification of risk by investing primarily in equity and equity related securities of larger companies located in developed countries outside of Canada and the United States, primarily in Europe, Australasia and the Far East (EAFE).

Results of Operations

The Fund's net assets increased 27.9% to \$81.6 million from \$63.8 million at December 31, 2023. Of this change, \$12.1 million is attributable to positive investment performance and \$5.7 million was due to net contributions to the Fund.

The Manager assesses the Fund's underlying securities for liquidity on a quarterly basis. During the period the Fund has remained in compliance with National Instrument 81-102.

Over the twelve-month period, the Fund's series A units' return was 17.4% (after deducting fees and expenses paid by the series) in comparison to the MSCI EAFE Index (Net) return of 15.1%. All performance values provided are in Canadian dollar terms.

2023 went out with a bang as the MSCI EAFE Index posted a stellar return in the fourth quarter and posted strong gains for the year. Markets surged as investor sentiment shifted dramatically towards the view that central banks are not only done with interest rate hikes this cycle but are also on the verge of meaningful easing starting in 2024. In terms of relative performance, positive security selection, particularly in Technology and Industrials, was the main driver of outperformance. Sector allocation was also positive over the period. Reflecting the broad nature of the market's advance, most portfolio holdings delivered positive returns. Two Japanese companies were stand-outs. Disco and Tokyo Electron, both of which provide equipment used in the production of semiconductors, capped off outstanding years that defied what had been expectations for a cyclical downturn. We continue to gather evidence supportive of our fundamental investment theses: notably the missioncritical nature of their equipment, the high barriers to entry given the incredible complexity of their technology, and well-aligned management teams. Strong fundamentals and organic growth also boosted the performance of reference data providers Wolters Kluwer, RELX and the health care company Novo Nordisk. Meanwhile, Anglo American miner saw its share price fall due to weakness in the commodity prices.

Some of the prominent initiations included Chugai, a pharmaceutical company, with strong internal R&D capabilities and is majority-owned by Roche, and SG Holdings, the second-largest Japanese delivery and logistics company, and can be thought of as the FedEx of Japan. We also reinitiated in brewer Heineken Holding, a company we exited in early 2022 given major input cost headwinds. Those headwinds are set to become tailwinds with the stock trading at what seems to be an attractive valuation. Meanwhile, we exited Recordati, a niche Italian pharma company, in favour of better risk-adjusted opportunities elsewhere.

Now, a very simple model is that equity markets are driven in the shortterm by four factors: earnings, rates, events, and investor sentiment. Looking ahead to 2024, we know that war, regulatory actions, geopolitics, and new technologies have the potential to move markets. Investors seem hyper-focused on how central banks will manage rates and whether economic demand will remain as resilient as it has so far. Seven of the world's ten most populous countries are headed to the polls in 2024. And to borrow from Benjamin Graham, Mr. Market's notoriously fickle sentiment can change quickly.

Thankfully, our investment process doesn't rely on such broad-based macro assessments. Its focus is much longer-term and more bottom-up in nature. More precisely: identifying companies that can create wealth by generating returns on capital in excess of their cost of capital for many years by virtue of sustainable competitive advantages. When led by excellent management teams, the wealth-creating nature of these business models can be enhanced and extended. By focusing on companies whose goods and services provide genuine value to their customers, the risk (though can never eliminate) is reduced that events or shocks fatally impair their business models.

Recent Developments

There are no recent developments to report related to the strategic positioning of the Fund, the Manager, or the policies of the Independent Review Committee.

Related Party Transactions – Management Fees

The Portfolio Advisor receives management fees, which are calculated for Series A Units as 1.10% per annum of the net asset value of the Fund calculated on a daily basis. Management fees for Series O Units are payable directly to the Manager by Series O investors and not by the Fund.

The Manager of the Fund has the ability, at their discretion, to reduce the management fees for large investors. This reduction is effected by means of a management fee distribution and will be automatically reinvested in additional units of the Fund at the net asset value of the Fund on the date of distribution. Mawer also receives fees for performing administrative services. As at December 31, 2023 the Fund owes Mawer \$0 related to these administrative services.


The Fund's performance numbers assume that all distributions are reinvested in additional units of the Fund. 
