## Investment Strategy

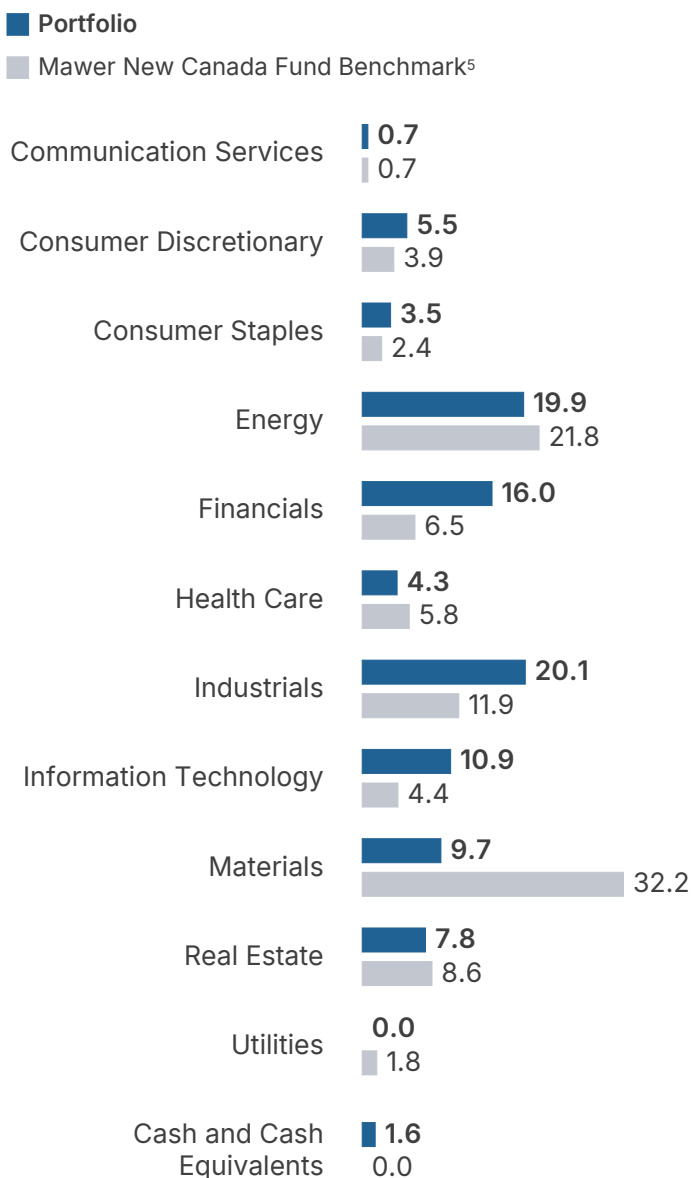
