## Investment Strategy

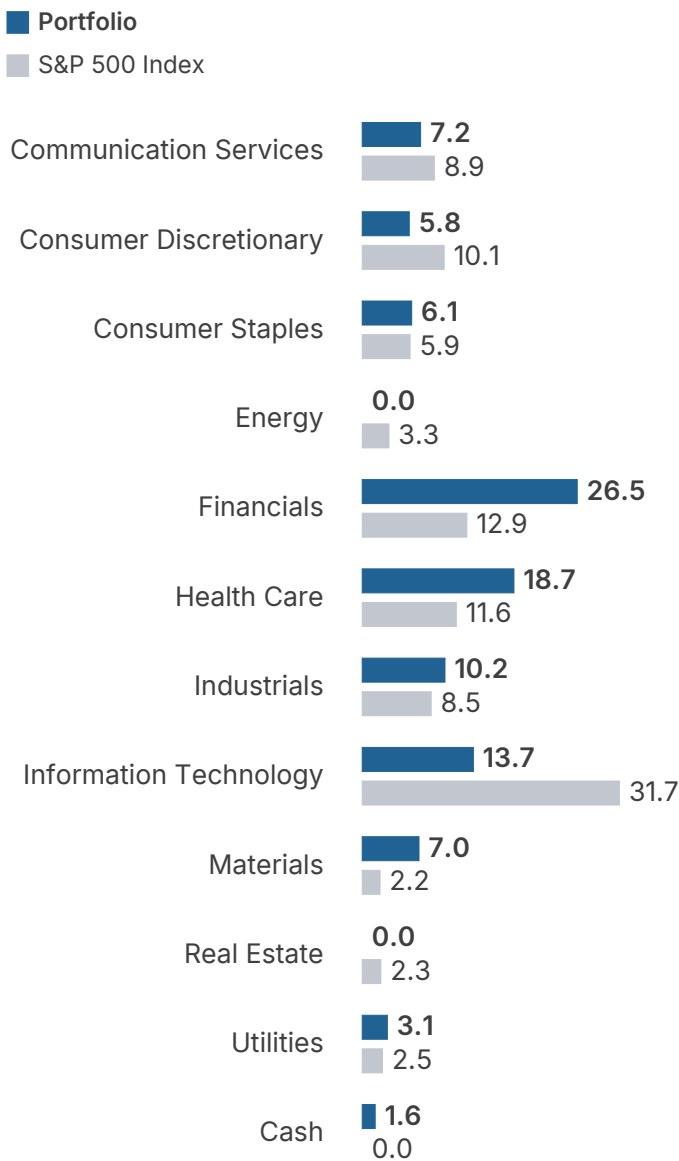
