Investment Strategy

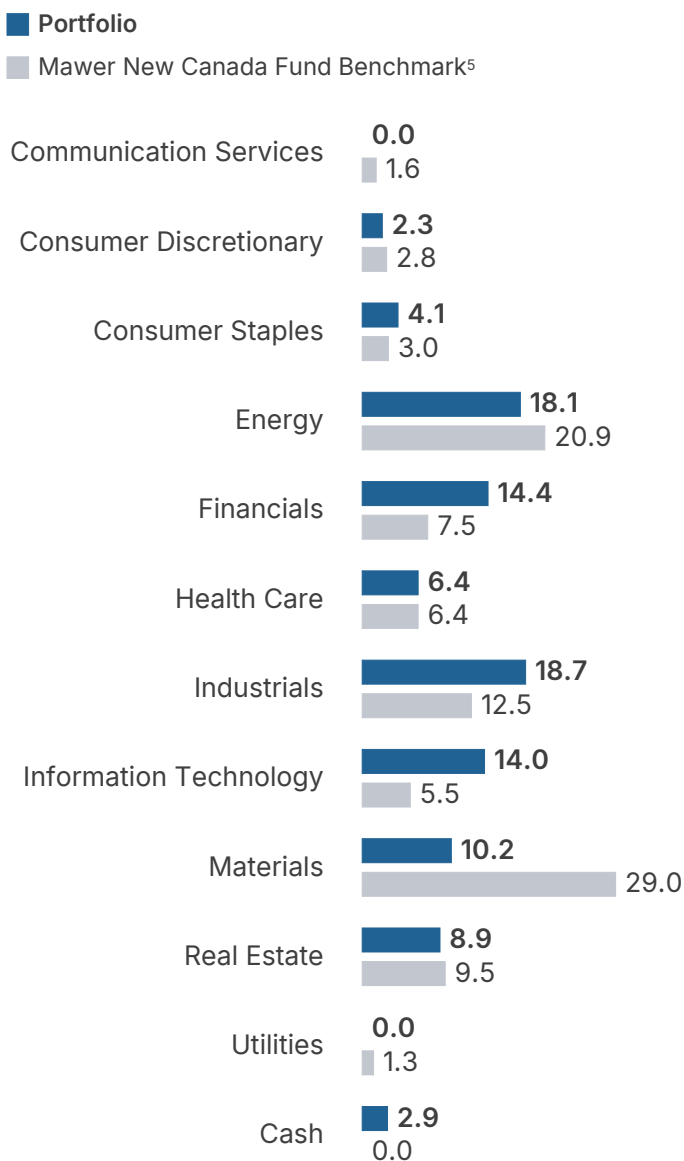
